Online Version of TSCJ to Focus on Pedagogy



TSCJ Call for Submissions At the May, 2006 TSCA officer's Retreat, the Executive Committee voted to return to the practice of publishing only one print of the *Texas Speech* Communication Journal each year. The officers decided to authorize the online publication of a second issue of TSCJ each year, limiting the focus of the online version of the journal to pedagogical issues. Therefore, in accordance with this directive, the Texas Speech Communication Journal issues a call for manuscripts and teaching ideas that focus on instructional practices in communication. Contributors are encouraged to include links in their submissions which would allow readers to click on relevant websites. (For an example of an online speech journal, go to the American Communication Journal website http://acjournal.org). This online format will allow contributors to include visual images, as well as links that support their research or explicate a teaching strategy. Manuscript submissions should be limited to 500 to 1000 words and should follow the format of other online newsletter publications such as Flow http://www.flowtv.org Articles for the online version of TSCJ should fall between academic and journalistic discourse and should be designed to promote discussion, raising important issues about the teaching of communication. All submissions for the first issue of TSCJ Online should be received by November 15, 2006. STATE BOARD OF EDUCATION REPORT

Dear TSCA Membership:

I know you have all been very anxious to know the content and direction of the SBOE meeting on July 6/7. Three of our members spoke at the meeting: Janice Caldwell, Russell Kirkscey, and Richard Cheatham. When they arrived and received the volume of pages they call the Agenda, they quickly went through the information to find the specific reference to our required speech credit. It was located in the Agenda that a board member had requested discussion on removing two required courses – one being Communication Applications. Here is the exact wording:

The paragraph is in "Withdrawal of and First Reading and Filing Authorization of Proposed Amendments to 19 TAC Chapter 74, Subchapters A and F (Attachment III)" under "Changes to Subchapter F"

The paragraph states:

"A board member has requested that consideration be given for further amendments to Subchapter F, including removal of graduation requirements such as Communication Applications and Foundations of Personal Fitness, to adjust for new graduation requirements outlined in HB 1."

The morning began with Senator Shapiro and a representative from the House discussing the new requirements in Math and Science. Before they left, Chairperson Miller said she hoped they would dispel a rumor that there was talk of removing two required courses to make room for the new math and science requirements. Our three representatives discussed whether there was a need to continue with testimony and decided to go forward despite Ms. Miller's comment because it was on the Agenda. Good move! Apparently most of the board members did not even know that this item was on the Agenda at the request of one board member. (This request is what prompted our action of emailing/calling/mailing in support of our discipline the weeks before the meeting.) Janice, Russell, and Richard practiced what we preach, analyzed their audience, slightly revised their testimony before speaking and did a wonderful job of representing our discipline. Most of the outside testimony came from Math and Science teachers, but there were also a few representatives speaking for the Arts areas. Richard was next to last on the agenda that included some thirty speakers, and since it had become obvious that the one board member who had asked that Comm Apps be discussed on the agenda had already backed away from any formal desire to see the issue on the table, Richard decided to depart from his prepared remarks and speak on behalf of the fine arts AND other speech courses that are currently being taken as electives. The new proposal would reduce the number of electives on the Recommended Program to 1 and 1/2 and on the Distinguished Program to 1/2. Consequently, he adapted his comments to the appeal to "build the cathedral of math and science" without using

the stones of the "temple" of either COMM APPLICATIONS or the electives. He asked the board to simply INCREASE the number of units required for graduation to total 26. Hooray for Richard! It appears they listened carefully. Below in red is an email received from Board Member Pat Hardy on July 10th:

The State Board of Education met last week. Your course in Communication Applications has the complete support of all of the members of the SBOE. It was never even under consideration to drop the course required for high school graduation requirements. I for one realize the value of the course and would have fought to maintain its place in the graduation requirements.

The SBOE is considering the raising of the number of high school credits to 26 to insure that the fine arts are not cut out for the core requirements. Please let this be known to other communication application teachers.

We will continue to keep our ears open to protect our other speech and theatre electives, but judging from Pat Hardy's comments everything is valued. I want to thank all of you for your support and help when having to make tough decisions. This was not fun. My stress level was probably the highest it has been in my life time. With every decision I made, I called on many individuals whether it was TEA representatives, Governmental Affairs Committee Members, seasoned TSCA members that understand the SBOE, or teachers of the Communication Applications course in order to gain insight. I have learned a lot from this experience as your President that I will pass on to future leadership in having to deal with the TEA and SBOE. I am thankful the outcome was positive and that we represented ourselves with integrity and professionalism.



The conference theme, **Creating Sites for Connection and Action**, represents an opportunity to build on work undertaken in Boston (2005) to assess the health of the discipline. Meeting rooms will be located at the Henry B. Gonzalez Convention Center, the San Antonio Marriott Riverwalk, and the Hilton Palacio del Rio. Convention highlights include the following:

This workshop is open to all NCA members attending the convention as well as local K-12 teachers from the State of Texas . Audience members will be introduced to the NCA Standards for Communication Fundamentals and then be led through hands on activities that can be used in language arts/communication classrooms. Participants will learn how competent communicators demonstrate a knowledge and understanding of the relationship among the components of the communication process, the influence of the individual, relationship, and situation on communication, the role of communication in the development and maintenance of personal relationships, and the role of communication in creating meaning, influencing thought, and making decisions. The course will also cover how competent communicators demonstrate the ability to demonstrate sensitivity to diversity when communicating, enhance relationships and resolve conflict using appropriate and effective communication strategies, evaluate communication styles, strategies, and content based on their aesthetic and functional worth, and show sensitivity to the ethical issues associated with communication in a democratic society.

Call for Manuscripts

Texas Speech Communication Journal Volume 32

The last five years has seen a dramatic increase in the number of online course offerings and degree programs, both for secondary and post-secondary students in the United States. In 2000-2001, 90 percent of public 2-year and 89 percent of public 4-year institutions offered distance education courses (U.S. Department of Education, National Center for Education Statistics. (2003). Distance Education at Degree-Granting Postsecondary Institutions: 2000-2001, NCES 2003-017, Executive Summary). College-level, credit-granting distance education courses were offered at the graduate/ first-professional level by 52 percent of institutions that had graduate/first-professional programs. Many college administrators have viewed online course development as a way to increase enrollment. The discipline of communication has followed this trend by creating online course delivery for the basic course, as well as upper level courses. The Texas Speech Communication Journal issues a call for papers that focus on the challenges and opportunities of teaching communication courses online. Contributors may approach the topic from a variety of perspectives: rhetorical, research based, narrative, and experiential. Teaching Tips submitted for Volume 32 should reflect best practices in teaching communication in a web-based environment. Manuscripts should be received no later than October 15, 2006. Manuscripts not devoted to the topic of online course delivery will be considered for the research section of the issue as space allows. TSCJ follows a policy of blind review so no author identification should appear in the body of the manuscript.

Manuscripts should not exceed 25 pages and be written according to the *Publication Manual of the American Psychological Association (5th edition)*. The title page should include the author's name, academic position, institutional affiliation, full mailing address, telephone number, email address, brief author bio, and a history of the manuscript (presentation at conferences). An abstract of not more than 150 words should accompany the manuscript. The author should also include keywords for the article. Email submissions are preferred for both manuscripts and teaching tips (either in WordPerfect or Word.). The format for Teaching Tips should include learning objectives, description of preparation needed for the activity, a description of the activity, instructions for debriefing and a list of resources. Book reviews for this issue will focus on teaching online and online course development. If you are interested in writing a book review, contact
