A Message From TSCA President, Ralph Long

Dear Texas Speech Communication Association Members:

Greetings. As the summer break draws to a close, and we all gear up to be back in school, I want to share some TSCA news, reminders, and updates with you.

News concerning TSCA and the Communication Applications (CA) class v the Professional Communication (PC) class can be read in the email from a TEA official that I asked Brent to post. I have also asked that he post my testimony. The questions in the email were generated out of concern created during the State Board of Educator Certification (SBEC) public hearing in Austin on June 18, 2010. I attended this hearing and spoke on behalf of TSCA. The meeting took all new classes and rolled them into one single agenda item. Originally each subject was a specific line item. This combining caused speech and other classes to be overshadowed by the math and science classes. Based on that fact, I had questions that needed clarification. To be brief, any currently certified speech teacher can teach the new PC class **without** any additional credits or training required. The CTE staff must obtain 6 hours of communication in order to teach the class. My testimony addresses TSCA's concern over this low requirement for CTE staff to be credentialed. The reality seems to be that many districts are opting to teach the PC class as it is funded at a higher rate from the state than is CA. Since the PC course is listed, by SBOE mandate, as an equivalent class to CA each district's decision as to which course to offer is, according to TEA, a local option prerogative. This is still an issue for Governmental Affairs to take a serious look at and work with the officers to monitor and have input over the course of the PC implementation.

Now, for the reminders and updates. As you know the 2010 convention is being held in Houston October 6-9, 2010. *Cultural Communication: Creating Community or Chaos?* is the convention theme. Please get your room reservations in. Also, please remember that it is important for the organization to meet the contractual room nights for the convention. If we do not do so the organization stands to take a significant financial hit. I know that it is tempting to make reservations on the many self-booking sites but doing so creates a financial hardship on the organization as we do not get credit for those rooms toward our contractual minimum room nights when you do.

Kandi King is creating the program and there are many wonderful sessions that have been submitted. I am particularly excited about Professor's Reading Hour. Dr. Peter Pober, former TSCA President and long time UT forensics coach, is doing a one man performance. To call anything Peter does "one man" is a misnomer. If you have ever seen Peter perform you know that he morphs so seamlessly and brilliantly from character to character that you forget that the same person is portraying all the personas. If you have never seen Peter perform then you must put this on your convention schedule. His program, *If I Were a Rich Man: Tales of an Unlikely Academic* will be a convention highlight.

Guy Yates has decided that a wonderful trip to exotic lands is more enticing than Houston, Texas in October so he will not be attending convention this year. Therefore, I have asked M'Liss Hindman to chair the Fiscal Review Committee and have asked Wade Hescht to serve on the committee for the review of the financial records at the convention.

Furthermore, be sure to check the convention schedule and plan your arrival and departure for convention so that you are able to attend your organizational meetings and fulfill the obligations connected to your service to TSCA.

As summer's song begins to wane and autumn begins to jot the first notes of its symphony remember to make your reservations at the convention hotel, plan your arrival and departure to allow your attendance at your respective organizational meetings, and plan your program panels to include the Professor's Reading Hour where Peter Pober will pack prose, poetry, and play passages into a puissant performance. However, most importantly, enjoy the school year and remember why, out of all the careers you could have chosen in life, you chose to teach. Bring that joy, dedication, and vision to your classroom and students each day and your rewards will be immeasurable.

I look forward to seeing all of you in Houston.
