## Speech In or Out of "The Block?"

In a recent email to TSCA members, Vice President Russell Kirkscey noted: "The Texas Higher Education Coordinating Board made substantial changes to several areas of the core curriculum for Texas colleges and universities that will take effect in the fall of 2014. The total number of semester hours in the revised core curriculum recommendations is 42, with six hours mandated for communication courses instead of the traditional nine hours. Some colleges and universities may allow students to take two English composition courses for their six hours and forgo taking a speech communication course."

Faced with budget cuts and mandatory modifications to staff, many post-secondary institutions have made the choice to cut foundational speech courses. The Block, the collective name for undergraduate prerequisite coursework, can vary slightly from school to school, and therein lies the problem.

M'Liss Hindman stated, "I have been involved very heavily in this issue on my own campus. However, the real problem is that each college can make its own policies, so it is difficult to present a united front about these cuts."
