TSCA has served as a valuable resource since I began my career as a debate coach. It is a valuable source of professional development for coaches across the state. The important role of member development should not be overlooked. As school budgets continue to face constraints, TSCA must look closely at the value of the professional development provided. Panel programming should be viewed from the lens of administrators facing impossible budget decisions. Convention must provide clear value to districts if our members are going to have the opportunity to continue to attend and benefit from the professional development provided. We must take a hard look at whether what we have always done is what we should continue to do.

In the current political landscape, the advocacy role of TSCA simply cannot be overlooked. Advocacy requires constant engagement with leaders at all levels of government. Members should receive frequent messaging from TSCA regarding legislation and policies that affect education broadly and speech education specifically. Producing white papers regarding certain policy decisions certainly provides value to our membership. However, as our members continue to be asked by their districts to take on more and more responsibilities, it is also our responsibility to provide quick access to information. The officers do not have to take the sole responsibility for the organization's advocacy. The officers should create situations and provide the information necessary for the members to advocate for speech education and education broadly.

If elected, these two areas will serve as my focus. TSCA has done so much good for coaches and educators for many years. We can't let good be the enemy of great.
